

HumanCare Russia

The HumanCare Russia association was founded in Bethlehem parish, 30.01.2010.

The initiative is based on the social work of the Russian Orthodox Church in Russia and has since 1991 started from the association "Aid to Russia", formerly the "Paul Society". It's association's purpose is to support Connie Meyer's humanitarian work in and around Moscow. Connie Meyer settled in Moscow in January 1992 and has since been involved in concrete projects that educate doctors and teach young people, provide medicine for children, support child-bearing families, single mothers, and disabled and elderly without relatives - and much more. Total for 27 years until May 9, 2019, where she passed away. At an extraordinary general meeting, members agreed that Connie Meyer's work should continue.

Association Statutes

- § 1 The name of the association is HumanCare Russia
- § 2 The Association's registered office is Copenhagen.
- § 3 The purpose of the association is to support the humanitarian work of the Russian Orthodox Church, by providing humanitarian support of various kinds to families, individuals, institutions and through projects.
- § 4 The association is funded through membership fees, donations, fund applications etc. clauses on donations must be respected.
- § 5 The quota is fixed by the general meeting. Membership is obtained through payment of the quota.
- § 6 The association is chaired by a board of three maximum 5 members elected at the general meeting. The board of directors constitutes itself. The members of the Board of Directors are elected for two years. Re-election can take place. In even years, 2 members of the board are up for election and in odd years the rest of the members are up for election. 1 alternate is elected for 2 years. 1 auditor is elected for 2 years. The Board of Directors holds at least 3 meetings annually, and as often as deemed necessary. Exceptionally, meetings can be held as telephone-skype meetings. The Board regularly informs the members about the economy, special needs and the current situation in Moscow through an information letter (primarily by mail). Members without mail are welcomed by ordinary mail. The board edits and maintains the association's website.
- § 7 The general meeting is the highest authority of the association and is held annually and no later than 30 April. Notice of general meeting must reach the members via letter of information 3 weeks before the meeting.
- § 8 The association's financial year is the calendar year. Audited and signed accounts must be available before the general meeting.
- § 9 The day-to-day management of the association is carried out by the boardconsisting of chairman, deputy chairman and cashier. The Executive Committee draws the association...
- §10 Amendments to these articles of association require a 2/3 majority at an ordinary general meeting. Resolution on dissolution of the association is made by the general meeting by a 2/3 majority in two consecutive meetings, held at least 14 days and a maximum of 1 month apart. In the event of dissolution, the general meeting decides any event. use of profits in accordance with the purpose of the association.
